The KZN Pro Bono advice office has been open and running 'in-person' (i.e., allowing clients to physically attend the advice office) since March 2021. Prior to this, SASLAW took steps to try to ensure that the needs of those seeking advice and assistance were still met during lockdown and prospective clients were able to contact our administrator via telephone or email, and the in-take of matters and allocation of matters to attorneys was undertaken virtually. The 'in-person functioning' has been going well and our attorneys are given the choice of attending physically or consulting on the day via teams. The number of clients being seen is now steadily increasing again.

In addition, the 2020/2021 year saw the implementation of both the 'KZN SASLAW/ Durban Labour Court Virtual Hearing Initiative' and the 'KZN SASLAW/ UKZN Street Law Initiative'.

The Virtual Hearing Initiative, made possible by the sponsorship and volunteer members, provides litigants who do not otherwise have access to virtual platforms for the hearing of their matters, access to facilities such as Wi-Fi, computers, and virtual platforms. Volunteer members offer their own facilities on their premises for this purpose. By way of sponsorship and donations, the Pro Bono advice office offers access to Wi-Fi and a laptop computer, with strict COVID-19 protocols such as screens, social distance marked seating and tables, and hand sanitiser. The generous sponsorship of our members should allow for the running of the initiative for at least the next 12 to 18 months.

The Street Law Initiative has seen UKZN Street Law students placed on a rotation at the advice office, providing in-take, translations, and related assistance. The students will also create easily understandable educational material (translated into different languages) for the benefit of those seeking advice from the office. Not only is this initiative to the benefit of the clients of the advice office, but also allows for law students to be exposed to the practicalities of litigation and labour law.

FINANCIALS

The Chapter's financial position remains stable despite the COVID pandemic having a noticeable effect on membership and payments thereof. Membership invoices were sent out in March 2021. Our Virtual Hearings Initiative remains available to those litigants who do not have access to virtual platforms for hearings, as well as for use by the Pro Bono Office, allowing attorneys to assist virtually and/or 'in person'. We thanks those members who have generously donated to this Initiative.

We have a steady stream of clients weekly and are currently in discussion with Legal Aid in Durban regarding increased involvement and assistance. Not only will this benefit the Pro Bono office, but it will strengthen the relationship with this important stakeholder.

We have identified that a new law clinic has opened under the auspices of Varsity College and that there appears to be room for a mutually beneficial relationship to develop between our Pro Bono office and the law clinic. We look forward to building that relationship.

In terms of a partnership with the University of Torono & Western University, SASLAW Probono NPC is hosting a number of students from Canada, allowing for exposure to the South African Labour Law systems. The Canadian students have been in KwaZulu-Natal this past week and they have been hosted by a few local volunteer firms and attended the Durban Labour Court and the Pro Bono Office.
